TERMS OF SALE

This cat/kitten is being transferred in good health. Buyer must have a complete examination by a veterinarian of his/her choice within 3 days of purchase to certify cat/kitten's health or to determine any unusual conditions. All veterinary fees are the sole responsibility of the Buyer.

Cat/Kitten is guaranteed against all hereditary defects up to the age of one year old. If cat/kitten is found to have an untreatable or life-threatening disease that is felt to have been contracted at the Seller's home (documentation required by the licensed veterinarian and, in the case of HCM, by an expert in the field of feline cardiology), or IF CONDITION IS TO RENDER CAT/KITTEN UNSUITABLE AS A PET, Buyer will be offered a replacement cat/kitten. Contract may be null and void should other animals in the home not be up to date on vaccinations that may cause the cat/kitten to become ill.

Seller reserves the right to verify all reported conditions by Seller's veterinarian prior to executing replacement or full refund guarantee.

Seller agrees cat/kitten will be kept indoors and not allowed to roam freely outside.

This cat/kitten cannot be resold, surrendered to any type of animal shelter or exchanged in any other type of animal sale or surrender for any reason. CAVSCOUT BENGALS RESERVES THE RIGHT OF FIRST REFUSAL AND PLACEMENT APPROVAL IF BUYER FOR ANY REASON WISHES TO PLACE CAT/KITTEN WITH ANOTHER OWNER. NO monetary refund shall be made if cat/kitten is to be rehomed.

Cat/Kitten is being sold as a pet. Cat/kitten MAY be shown if agreed upon by both parties. If that is the case, periodic evaluations will be made as to competitive quality. TICA registration will be held by breeder until cat/kitten has been spayed or neutered and a copy of certificate has been received. Cat/kitten may be placed under co-ownership agreement during its show career.

No TICA registration transfer will take place until full payment and copy of spay/neuter certificate has been received.

Seller reserves the right to use photos of cat/kitten sold to buyer in any/all advertising, including website advertising, in the promotion of the Seller. Buyer agrees to allow Seller the right to use cat/kitten's photographs or name in the future or existing advertising. Buyer agrees to identify this cat/kitten by its full registered name on websites or in advertising at all times.

Any disputes with this contract will be governed in accordance with the laws of the State of Massachusetts. Any court proceeding in regards to this contract shall take place in Plymouth County in the State of Massachusetts.

Disputes regarding this sale or contract will be handled privately and NOT aired in public forums or social networks by either party. This contract is confidential between Seller and Buyer.
